Creekside Trail

Hidden Falls Regional Park, Placer County, 8 miles west of Auburn

Introduction:

On May 22, 2013 opening ceremonies were held on the new expansion for Hidden Falls Regional Park. The newly-constructed 23 miles of trails on 961 newly-acquired acres of the Spears Ranch (\$3.5 million) brings the total to **thirty miles of public trails** and **1,300 acres** of park land for Hidden Falls Regional Park. This is huge accomplishment will directly benefit equestrians who are conditioning for endurance rides (such as the Tevis Cup), or who want to train their horses for mountain trails.

Sustained credit belongs to Andy Fisher, Senior Planner for Placer County, who worked diligently for many years to achieve the complicated financing that was cobbled together from diverse sources (≈ state bonds, park acquisition funds, and open-space grants). This was a hard-fought battle through the Placer County Planning Commission and the Placer County Board of Supervisors. Loomis Basin Horsemen's Association testified and presented letters to support the expansion of Hidden Falls as a regional county park with multi-use trails. LBHA had broad support from sister equestrian groups.





Background on New Trails and New Bridges:

The overall trail system was designed by Senior Planner Andrew Fisher of Placer County. The overall improvements (new bridges, new trails, access road, brush clearing, eight foot-bridges, observation platform, gravel, rip-rap boulders, culverts, etc.) cost about \$4.6 million. Annual maintenance is about \$211,000 to operate Hidden Falls Regional Park. There is no charge to use the park.

Construction of the two large steel truss bridges across Coon Creek was by Wescon Construction of Newcastle (Keith Kenworthy, manager).

The looping trail system was constructed by Robert Dawson, Placer County Parks, with sustained assistance from Mark Porter.


The contractor for trail-construction was Donald R. Hays, a licensed professional trail builder from Tahoe City. For most of the new trails, a Bobcat tractor was operated by Douglas Hulett.

Eight footbridges were constructed by the California Conservation Corps.

A large amount of brushing and chipping of vegetation (manzanita, blue oak, bay laurel, California buckeye, poison oak vines) was accomplished by prisoner work-crews from the Washington Ridge CDF Conservation Camp on Highway 20. These are convicted felons (initially from Susanville State Prison), who have committed non-violent felonies, and who are now in an "upward transition" back into society. We appreciate their difficult work in the burning hot sun on steep terrain.

Two Large Steel Truss Bridges

For access across the rock gorge of Coon Creek, it was necessary to construct two large steel-truss bridges at a cost of \$1.48 million. Horses and hikers cannot cross Coon Creek in this region, and the new park ranchland occurs on both sides of the incised creek. Canyon View Bridge is 102 feet long and rated at 18-ton capacity, while Salmon Run Bridge is 118 feet long and rated at 36-tons.






Extensive Trail System = 27 Trails

On the south side of Coon Creek there are 13 named trails, and the north side has 14 trails, for a total of **27 named trails**. Most of them are looping trails and interconnected, which is ideal for equestrians. This report is about Creekside Trail which is linear and connected with the North Legacy Way, a full-width graveled access road that is used for park maintenance vehicles.

There will be subsequent trail reports on more than a dozen other trails that vary from Easy (11 trails), Moderate (12 trails), to Difficult (4 trails).


Creekside Trail, 2.4 miles long; rating = "moderate"

The segment between the two large bridges is covered by Creekside Trail along the north side of Coon Creek. It is parallel to the rocky gorge of Coon Creek, with access for horse water at only two locations (west end at Salmon Run Bridge, and the central area).





There are only two switchbacks along the Creekside Trail, and both are on the eastern end along the steep descent from the graveled road (North Legacy Way). PAGE 8 LBHA NEWSLETTER





These are Copper Hill Volcanics of the Jurassic Period. These blue-gray metavolcanic rocks have been sheared along the nearby Bear Mountains Fault Zone (\approx one mile northeast) so that foliation planes are well-developed with a strike azimuth of N±30°W, and near-vertical dip ±80°SW. During 2012 trail construction, these flat boulders were cleverly used by Donald R. Hays, licensed professional trail builder, to strengthen the outside shoulder of Creekside Trail.



The Undersigned acknowledges that horse-related activities are dangerous and that horses themselves have unpredictable temperaments which can sometimes cause injury. The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS IN-HERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1.
