Mark Pecotich gave a report on a recent meeting he and Debbie Murphy attended regarding a Trail
Alignment project along the Granit Bay Loop. He stated that multiple trail users were present and offered a positive dialogue on how bikers, equestrians and hikers could all share the resources. Before anything could be decided, however the Parks and Recreation Department still needs to do an environmental review. This report will probably not be completed until next spring. Mark also mentioned that a request has been made to do a "brush out" on the Forest Hill Divide.

The Ranch Horse Class needs to be moved to later in the day. Lastly we need to add our helmet rule onto the show programs.

# Horse Trail Safety Advisory Message 

# New Bridge Under Construction at Canyon Creek (the waterfall) 

Western States Trail near Tevis Milepost 97, Auburn State Recreation Area

A new 34-foot long wooden bridge is under construction during November 2014 at the waterfall along the Tevis Trail near Milepost 97, within Auburn State Recreation Area. Work is being performed by the California Conservation Corps based out of Greenwood in El Dorado County. Construction will take perhaps a month, depending on weather and logistics.

Although this trail segment will remain open during construction, it is advisable for safety reasons for horsemen to temporarily avoid this trail segment during weekdays.

The large timbers could be spooky, perplexing, and startling for most horses, and there is no lateral escape. Heavy timbers will be brought in for construction, and this freight can be spooky for horses. Conversely, hikers can easily navigate during bridge construction.

So: the safety advisory for horsemen is to simply ride elsewhere during November 2014.
The Canyon Creek waterfall is a caused by a leak in the PG\&E flume. The waterfall is seasonally lower in November, and it is cooler weather for the construction crews. A large fig tree was removed last winter, and the bridge alignment was brushed-out in anticipation for this new construction.


At left: The Tevis Trail crosses Canyon Creek approximately at Milepost 97. The new timber bridge will be constructed on the outside near the location of the former fig tree. The bridge deck will be elevated far above the creek.


At right: The steep horse trail around the concrete abutment of the historic railroad bridge. This will be the first view of the new timber bridge for your horse during construction. So it is best to simply avoid this potentially spooky view, and ride elsewhere.


Conveniently located near Horseshoe Bar Road and Auburn Folsom Road and within riding distance to the Folsom Lake trails. Knicker Knob has long been known in the Gold Country equestrian community for producing safe and knowledgeable horsemen.
