Round Table Pizza Meeting Room

The meeting was called to order by Vice President Maureen Henderson at 7:00 PM

Attending members introduced themselves.

There was no treasurers report.

Dave Faoro gave a Traylor Ranch report. He stated that the California Conservation Corp did a major cleanup of the blackberries along the paths and trails. He is still trying to get the county to bring the sheep and goats for additional brush cleanup. Beaver dams are still causing a flooding problem on the paths. He gave a reminder that the monthly scheduled clean up days are the 4th Saturday of every month.

Debbie Murphy attended the Bike Pump Trail meeting with the ARD. Her report is posted on the LBHA web page.

Kathy Dombrowski reported that, according to the County, the LBHA arena will have the watering cut by 20%. Riders who use the arena regularly need to notify LBHA as to the most heavily used days and times so watering can be coordinated accordingly.

Debbie Murphy introduced our Guest speaker Kathy Roberts.

Kathy is a team roper and local rancher who offers cow clinics for people who wish to learn about working with cattle. She described various techniques necessary for working cows. She stated that working with cows is very similar as to working with horses. Kathy said that position and pressure are the two most important concepts that riders need to understand. Her clinics are slated towards beginners and to people who want to introduce their horses to working cattle.

American River Classic AERC Endurance Ride

Saturday, April 26, 2014

Granite Bay to Auburn, then onward to the Olmstead Loop at Cool, and then back to Auburn

This is photo-collage of this 50-mile endurance ride, that also included a simultaneous 25-mile Limited Distance ride. The American River Classic is the oldest sanctioned 50-mile endurance ride in the world, beginning in 1972.

The Ride Manager is Paul Klentos and the Assistant Ride Manager was George Putnam. Heidi Smith served as the Webmaster. The Head Veterinarian for 2014 was Dr. Melissa Ribley, with Dr. Robert Morgan and Dr. Michele Roush at the vet-checks. There were over five dozen volunteers, mostly experienced riders.

The ride-camp was at Granite Bay, in a gravel quarry located east of the assembly area. Overflow parking for horse trailers was located in the adjacent large asphalt parking lot that is normally used for boat-trailers.

On Friday afternoon, April 25, there were intermittent thunderstorms passing through Folsom Lake, so the entire ride-camp was wet. Vetting was performed on the crest of a dike which had good footing for the horses. On Saturday, the weather was favorable, blue skies with some clouds, and 65°F high.



The 50 - mile ride began at 5:30 AM, with the 25 - mile ride beginning at 6:00 AM. The 50 - mile ride went south from Granite Bay, around and over Mooney Ridge, then circled back through Granite Bay (brief vet - check at Mile 3), then north on the Pioneer Express Trail to Rattlesnake Bar (15 - minute vet - check with farrier services at Mile 17), then by spring wildflowers at Avery Pond, then ascend up the steep Cardiac Hill to the Auburn Overlook (60 minute gate - to - hold at Mile 25). This was the end for the 25 - milers, but the ride continued for the 50 - milers down the Tevis Trail across No - Hands Bridge, then up the Wendell Robie Trail to the Olmstead Loop, then to a vet - check near the Cool Fire Station (15 - minutes hold at Mile 43), then back down the Wendell Robie Trail to No - Hands Bridge, then up the Tevis Trail to the Auburn Overlook (Mile 50).



Crew members moved truck & horse-trailer rigs from Granite Bay to the Auburn Overlook, then set-up camp. We lugged ice-chests of food and hydration juices, crew bags of clean jodpurs, hay-bags for our horses, towels to wipe-down horses, folding chairs, buckets for wet mash and horse drinking water. Here is the camp of Robert Sydnor and Janet Fullwood (crew for two excellent riders from Tamber Bey Vineyards of Napa Valley), plus the Stalley Family from Williams in Colusa County.

Sharon Campbell (in the yellow vest) of the Sweep Riders of the Sierras is shown tacking-up her S.O.S. horse. The S.O.S. riding teams made sure that there was "No Rider Left Behind".

Mark Montgomery of Penn Valley
wins First Place and the
Barsaleau Pioneer Award on a Mustang.



Mark Montgomery, a horse trainer from Penn Valley in Nevada County won both First Place in the 50-mile AERC ride, and the Barsaleau Pioneer Award. Surprisingly, he won on a Mustang (with no pedigree) that he had obtained from the U.S. Bureau of Land Management in Susanville. This Mustang had never ridden the Pioneer Express Trail before, nor had he crossed No-Hands Bridge. This horse was fearless, perfectly conditioned by Mark, and was eager to overtake Registered Arabian horses with full pedigrees. So sustained training pays off with a double victory for Mark Montgomery.

Jennifer Waitte of Yountville in the Napa Valley finishes #2 on her gray Arabian mare, and Jenni Smith of Moraga finishes #3 on Stella, a well-conditioned Arabian mare that wins the coveted "Best Condition" Award. Riders must finish in the Top-Ten to be eligible to show for the AERC Best Condition Award. These two ladies on the Tamber Bay Equestrian Team coincidentally finished #2 and #3 in the 2013 Tevis Cup held last year, so they are considered formidable riders on a sustained basis.



The Barsaleau Cup - Pioneer Division - In honor of Richard Barsaleau, D.V.M., and in recognition of excellence in horsemanship, the Pioneer Division acknowledges riders who are the sole caretakers of their horse from the start of the ride to the final vet check. These riders cannot have any crew.

The Barsaleau Cup is awarded to the first horse in the Pioneer Division completing the 50 miler, carrying a minimum of 165 lbs (with tack).

An avid equestrian, judge, breeder and endurance rider, Dr. Barsaleau was a pioneer in establishing the initial parameters of examining endurance horses. As a head veterinarian and AERC rider, he strongly believed in the adage, "One Horse, One Rider, One Trail," and that a horse must "demonstrate the willingness and ability to go on" at the finish.

Dr. Barsaleau was an Honorary Member of Loomis Basin Horsemen's Association, and his obituary was published last year in our LBHA Newsletter.

RELEASE AND HOLD HARMLESS AGREEMENT

The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator. The Undersigned acknowledges that horse-related activities are dangerous and that horses themselves have unpredictable temperaments which can sometimes cause injury. The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1. I HEREBY RELEASE AND DISCHARGE LOOMIS BASIN HORSEMEN'S ASSOCIATION ("LBHA"), THE LBHA BOARD OF DIRECTORS, ALL LBHA OFFICERS AND INDIVIDUAL CLUB MEMBERS AND THEIR AGENTS, EMPLOYEES, OR REPRESENTATIVES, AS WELL AS PLACER COUNTY, (HEREINAFTER COLLECTIVELY KNOWN AS "RELEASEES") FROM ALL ACTIONS, CLAIMS OR DEMANDS I MAY NOW OR HEREAFTER HAVE FROM INJURY, DEATH OR DAMAGE RESULTING FROM MY PARTICIPATION IN ANY HORSE-RELATED ACTIVITIES SPONSORED BY LBHA, AT LOOMIS BASIN HORSEMEN'S ARENA OR AT ANY OTHER LOCATION.

2. I also EXPRESSLY WAIVE any rights I may have under California Civil Code §1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

5. I agree that I will DEFEND, INDEMNIFY AND HOLD HARMLESS Releasees against all claims, demands, and causes of action, including court costs and actual attorney's fees, arising from any proceeding or lawsuit brought against them due to any act done by me, or brought by me or for my benefit.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT CAREFULLY AND COMPLETELY, AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND RELEASEES, AND I SIGN IT OF MY OWN FREE WILL. I FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE, AND THAT I RELY ON NONE. THIS AGREEMENT SHALL REMAIN IN EFFECT UNTIL REVOKED IN WRITING BY ME.




